### \*Note:

- Mincing the meat through a coarser plate will result in a coarser textured product.
- Temperature after processing should not exceed 5°C

### Method A – using a mixer

- 1. Mince the meat and place in mixing bowl. (A coarser plate will give a coarser texture)
- 2. Add seasoning and mix well, to evenly distribute.
- 3. Add rusk and mix evenly to distribute.
- 4. Gradually add water (iced cold water) and mix.
- 5. Re-mince through a 5mm or 8mm plate to achieve desired texture.
