METHOD:

- 1. Dice the chicken and mix in the Lucas Tikka Pie & Pasty Mix. Mix thoroughly.
- 2. Add the cold water and mix thoroughly.
- 3. Place the filling into suitable pastry cases, *glaze using the Lucas pastry glaze 20053266 (Product recipe J18). This should be done prior to again 5 minutes before the end of baking. Bake in an oven at 190°C (375°F) for the required time.

STORAGE

Product must be stored under refrigeration or can be frozen.
