BEEFBURGERS - using a Formatic Style Burger Machine **Using Butchers Classic Beef & Onion Burger Mix 20267547** **(CONTAINS 82% BEEF)**

RECIPE:	%	lb	oz	Kg
Beef Meat (85VL)	82.5	8	4	3.746
Burger Mix 20267547	7.5	0	12	0.340
Cold Water/Ice	10.0	1	0	0.454
Total	100.0	10	0	4.54

Method using a mixer

1. Mince chilled beef twice to desired texture.
2. Re – chill the minced beef if the temperature exceeds 4°C.
3. Add burger mix and mix well, to evenly distribute.
4. Gradually add iced water and mix in until absorbed. Do not over mix.
5. Fill the hopper on the machine with the mix.
6. Start the machine and collect the formed burgers from the belt.

NOTE:

- The temperature throughout processing should not exceed 4°C.
- For larger batches, add the mixture to the hopper in small quantities (approx 3 – 4 kgs)
