Recipe:-

Chicken Meat (with attached fat and skin) Burger Mix 20757211 Cold Water/ice	% 85.0	lb 8	oz 8	Kg 3.86
	7.5 7.5	- T	12 12	0.340 0.340
Total	100	10	0	4.54

Method A – using a mixer

- 1. Mince the meat once or twice to desired texture.
- 2. Add burger mix and mix well, to evenly distribute.
- 3. Gradually add water and mix in until absorbed.
- 4. Press out burger to desired shape and weight.

Note:

- Mincing the meat through a coarser place will result in a coarser textured product.
- Temperature after processing should not exceed 5°C
- If the chicken is too wet, cut back on some of the water.

FORMING:

Form into burgers of the required size and weight on a suitable machine or press.
